Testimony of Art Owens, president of Sports & Health Club Regarding Gay Rights Bill - House File 109, House Judiciary Committee Hearing, April 11, 1984

"Mr. Chairman, members of the committee, my name is Arthur Owens. I'm president of Sports & Health Club. We have six locations in the Twin Cities area. We've been in business over 23 years, and up until about eight years ago, the sexual preference or homosexuality in our particular business was not a

In 1970 we opened LaSalle Court Sports & Health Club, and subsequently it became kind of a bayen for some of the homosexuals in downtown Minneapolis. My first awareness of it was when we started to get calls from our members telling me about the activity of the homosexuals and the gay group in our downtown locatio

Well, I didn't pay too much attention at the beginning, but as we started to lose business and people started to drop out, because this was their most convenient location, we looked into it and sure enough. there was quite a group down there and they were not using necessarily the other five locations.

We sent one of our managers down at that point to try to straighten it out, and we had to rid ourselves of quise a few before they realized we were not prejudiced against gays or the homosexuals as long as they did not practice their perversion in the Sports & Health Club. And if they ontinued to practice it they would be minus their membership.

And after quite a few were let go, the others started to straighten up, and last Friday I was down for evaluation, and again at the LaSalle Sports & Health Club with some of our staff people and they mentioned that they had just again took memberships away from two more that continued to display their sexual preference in an open way.

Lagree with what has been testified heretofore, and speaking from just a business point of view I can say that the outright, the outright expression of this openly, is repugnant to us as Christians and as Americans that are living in traditional standards. And we do lose business because of it and we will not be a party to it. even it it comes to the point that we have to close the place.

As you know. Minneapolis has a law like that, we have never been challenged on the Minneapolis law even though we are active in pursuing our particular part of it. I don't know why that is, but we will not as businesspeople consider that prefer-ence in acting out in our particular place of business.

Do you have any questions?\*\*

Rep. Staten: "Mr. Chairman, Sir, 1. guess two things: Number one, your business is already located in downtown Minneapolis, which is already covered by current ordinance, is

Mr. Owens: "Yes, sir."

Rep. Staten: "Number two, I guess, what would the concerns that you have, that you've raised, have to do with this particular piece of legislation, since any public display in terms of public affection and so forth is not covered in this legislation? The acts that you've talked about that have occurred --- nothing in this legislation would legalize

Mr. Owens: "The preference, the outright acting out of the preference and as you read the San Francisco experience, it's a step by step pro-

cess. That is, again we have five locations not in downtown Minneapolis. We would be, as I understand this bill, and I haven't read it in its entirety, but as I understand it. would be obligated to hire homosexuals if somebody could prove that they met all the other criteria. With us, obviously, they could not meet the other criteria. and so they would not be hired by us. But I'm not speaking only from a business point of view, but as a representative of those I know that are in business, that feel that the person that pays the real is probably the one that should set the climate, or the moral climate in the business."

Rep. Cohen: "Mr. Chairman, Sir. If I'm not mistaken, aren't you the individual or wasn't it your business that there was considerable amount of publicity about in regard to emplayment practices that were found by some people to be discriminatory that had nothing to do with homo-

may, what, as I understand it, peo-ple who didn't fit your concept of Christianity, they couldn't be retained as employees.

Mr. Owens: "No. sir, that is incorrect. Let me make a statement on that. We will not knowingly hire anybody that is antagonistic to the Gospel. We will not knowingly hire anybody that is actively involved in an immoral situation, and we will not as far as our business is concerned, and I think that you have probably been influenced by the paper reports, where most of our complaints have been of religious nature, it turns out to be an attitudinal problem, not of religious

Rep. Cohen: "Mr. Chairman, which Gospel is that?

Mr. Owens: "What do you mean, sir, which gospel is that?

### Rules for 'Sodomites'

Activity by Sodomites or normal people that is not morally or socially acceptable in the Sports & Health Club environment.

Examples: 1. Immodest attire

- Making out in the club.
- 3. Harassment of another member-male or female

We won't allow Sodomites to advertise their perversion, and set the tone of the Sports & Health Club to indicate a homosexual environment, or allow our reputation to be damaged by becoming known as a "Sodomite pick up

- Examples: A. Male and female may hold hands and not be offensive to normal society and our members. Sodomites would not be allowed to hold hands as this would be offensive by
  - formal and socially acceptable standards. Loitering in the workout area with other Sodomites for social reasons rather than the purpose of work out.

We will not allow Sodomites to create an environment that promotes homosexuality and makes normal members feel uncomfortable or reduces their enjoyment of the club

Loitering and congregating in the club that makes the normal member feel threatened.

Sodomites gain their strength in numbers.

Past cases include 1"-eye balling" normal male members. making sexually insinuating comments and 3-trying to pick up normal people. 4-Trying to recruit new Sodomites.

Sodomite congregating is stopped because they have a different motive than two normal people talking. They have a common bond in perversion and want to promote it in our club. This common bond is not present when normal people may congregate in the club.

The Sodomite situation is especially dangerous to our business because of the nature of the health club. Normal people can be made to feel uncomfortable very easily because of physical environment such as locker rooms,

For example we would not allow co-od shower facilities because of the obvious sex implications. People would be cycholling members of the opposite sex, both sexes would feel uncomfortable, etc. Reusons are so obvious its foolish to expand on it.

Although not quite the same, the Sodomites create a similar problem, Our normal members can now be made to feel uncomfortable in their own locker room, sauna and even in the workout room

We try to cut off problems before they arise by discouraging excessive congregating and loitering of the Sodomites. This is a judgement call we have to make as to when the Sodomites purpose for being in the club starts shifting from working out to setting a homosexual tone and environment to the club, we land on them like a duck on a junebug.

By not imposing the above rules we would --

- Have a damaged reputation
- 2. Reduce enjoyment of club for most members
- Lost income to club
- 4. Loss of membership sales

The offensiveness of Sodomite action and financial loss to the club does no change because Minneapolis now classifies those involved as a "minority.

But this is what I did on two recent Wednesday evenings when I attended the hearings on Don Potter's discrimination complaint against the Sports and Health Club, Inc. At least half of seven hours' hearing time was filled by one witness after another for the Sports and Health Club recounting the sins-real and imagined—of gay club members present and past
